431. Plaintiff Stephen Edens is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 175 New Meadow Road.

432. Plaintiff Myra Edens is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 175 New Meadow Road.

433. Plaintiff Karin Dreier is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 4 Willow Way and 6 Willow Way.

434. Plaintiff Harry Palagi, Jr. is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 60 Anoka Avenue.

435. Plaintiff Michael Keyworth is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 14 Knapton Street.

436. Plaintiff Kathleen Dod is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 47 Sowams Road.

437. Plaintiff Robert Dod is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 47 Sowams Road.

438. Plaintiff Robert Kilmarx is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 56 Elm Lane.

439. Plaintiff Sandra Hedlund is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 3 Greenbrier Drive.

440. Plaintiff Rino Dimarco is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 480 Middle Highway.

441. Plaintiff Helge-Caj Butler is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 33 Bourne Lane.

442. Plaintiff Kathryn Kain is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 80 New Meadow Road

443. Plaintiff Lester E. Grinnings is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 114 Shore Drive.

444. Plaintiff Linda J. Grinnings is a taxpayer of the Town of Barrington, Rhode Island and is an owner of certain real property and improvements thereupon situated in said Town and more particularly described as 114 Shore Drive.

445. Defendant Michael R. Minardi is a citizen of the Town of Barrington, Rhode Island, and is the Tax Assessor of said Town and is made a defendant herein in said capacity. Defendant Town of Barrington is a municipal corporation established under the laws of the State of Rhode Island.

446. Defendant Dean Huff is a citizen of the Town of Barrington, Rhode Island and is the Finance Director of said Town and the Tax Collector of said Town and is made a defendant herein in said capacities.

447. Defendant June S. Speakman is a citizen of the Town of Barrington, Rhode Island and is a member and President of the Town Council of the Town of Barrington and is made a defendant herein in said capacity.

448. Defendant Peter DeAngelis is a citizen of the Town of Barrington, Rhode Island, and is the Town Manager of said Town and is made a defendant herein in said capacity.

449. Defendant Jeffrey S. Brenner is a citizen of the Town of Barrington, Rhode Island, and is a member and Vice President of the Town Council of the Town of Barrington and is made a defendant herein in said capacity.

450. Defendant Kate G. Weymouth is a citizen of the Town of Barrington, Rhode Island, and is a member of the Town Council of the Town of Barrington and is made a defendant herein in said capacity.

451. Defendant James Schwartz is a citizen of the Town of Barrington, Rhode Island, and is a member of the Town Council of the Town of Barrington and is made a defendant herein in said capacity.

452. Defendant John T. Lazarro is a citizen of the Town of Barrington, Rhode Island, and is a member of the Town Council of the Town of Barrington and is made a defendant herein in said capacity.

453. Jurisdiction is properly in this Court pursuant to the provisions of R.I. General Laws § 8-2-13; R.I. General Laws § 44-5-27; and the Constitution of the State of Rhode Island; and the Rhode Island Declaratory Judgments Act, R.I. General Laws § 9-30-1, et seq.

454. Venue for this action is properly in Providence County pursuant to the provisions of R.I. General Laws § 8-2-27.

455. Plaintiffs bring this action individually, collectively, as taxpayers, and also as representatives of a class comprised of owners of real property in the Town of Barrington who will have taxes levied and imposed on their ratable property by the Town of Barrington apportioned based upon assessed valuations determined by or on behalf of said Town as of December 31, 2008, which valuations result in their bearing a disproportionate and unfair allocation of the burden of real property taxation in the Town of Barrington all in violation of (a) the "fair and equal distribution of burdens" clause of Article 1, Section 2 of the Constitution of the State of Rhode Island and/or (b) the requirement of R.I. General Laws § 44-5-12 that "all property subject to taxation shall be assessed at its full and fair cash value, or at a uniform percentage of its value" As set forth more fully below, the Town of Barrington real

property tax assessments as of December 31, 2008, systematically fail to conform to said standards.

456. As regards the class representation aspect of their instant claims, plaintiffs aver that (a) the class is so numerous that joinder of all members is impracticable; (b) there are questions of law or fact common to the class; (c) the claims of the representative parties are typical of the claims of the class; (d) the representative parties will fairly and adequately protect the interests of the class.

457. Moreover, the prosecution of separate actions by individual members of the class would create a risk of (a) inconsistent or varying adjudications with respect to individual members of the class which would establish incompatible standards of conduct for the Town; and (b) adjudications with respect to individual members of the class which would as a practical matter be dispositive of the interests of the other members not parties to the adjudications or substantially impair or impede their ability to protect their interests.

458. Further, the defendants have acted or refused to act on grounds generally applicable to the class, thereby making appropriate final injunctive relief and corresponding declaratory relief with respect to the class as a whole.

459. The nature and scope of this proceeding is such that questions of law and fact common to the members of the class predominate over any questions affecting only individual members and a class action is superior to other available methods for the fair and efficient adjudication of the controversy.

460. This action is not entirely coextensive with (and is indeed broader in scope than) the regimen for individual administrative appeals contemplated by R.I. General Laws § 44-5-26,

et seq. and corresponding provisions of local law, but may necessarily affect the results of appeals filed through that process.

Causes of Action

461. As citizens, real property owners and taxpayers of the State of Rhode Island, plaintiffs have a right under Article 1, Section 2 of the Constitution of the State of Rhode Island to be free from unequal or unfair distribution of the burden of local property taxation, and the corresponding burden of financing the operation of local government.

462. Plaintiffs have a further statutory right under R.I. General Laws § 44-5-12 to be free from local property taxation that is based on assessed valuations which systemically fail to reflect the full and fair cash value of the assessed properties, or a uniform percentage thereof, not to exceed one hundred percent (100%).

463. The assessed valuations determined by or in behalf of defendants as of December 31, 2008 for tax bills issued in 2009 have been determined in substantial part by an appraisal process conducted by Vision Appraisal Technology, Inc. of Northboro, Massachusetts (“Vision Appraisal”) pursuant to a contract between Vision Appraisal and the defendant Town of Barrington dated November 5, 2007 entitled, “Contract For The Statistical Reappraisal Of Taxable And Exempt Real Property Located Within The Corporate Limits Of Barrington Rhode Island Effective December 31, 2008” (“the Re-Appraisal Contract”).

464. Pursuant to the Re-Appraisal Contract, Vision Appraisal undertook “to make a complete statistical re-appraisal of all taxable and non-taxable real property located within the corporate limits of the Town [of Barrington].” (Contract para. 1). The Re-Appraisal Contract required Vision Appraisal to undertake “the complete re-assessment and revaluation of all

taxable and non-taxable real property within the corporate limits of the Town of Barrington . . .
.”

465. The Re-Appraisal Contract further provided that the values to be determined by Vision Appraisal pursuant to the aforesaid appraisal process “shall be the full fair market value, as defined in Section 44-5-12 of the Rhode Island General Laws . . .” as of December 31, 2008. (Contract Specs para. 2.1; 2.2).

466. The Re-Appraisal Contract further required Vision Appraisal to “comply with Rhode Island certification standards . . . for all personnel assigned to the project
. . . .”

467. The appraisal/re-appraisal work product generated by Vision Appraisal has been embraced by the defendants as the basis for the assessed valuations utilized for property taxation by the Town of Barrington as of December 31, 2008 for taxes levied and imposed during 2009.

468. Tax assessments, certifications of the tax roll, and any levy and/or imposition of real property taxes based on the appraisal/re-appraisal work of Vision Appraisal are invalid and unlawful and illegal in that they are based, inter alia, on flawed assumptions, formulas, methodologies and preconceived notions; inaccurate data; substantial arbitrary discrepancies in valuation as between similarly situated properties; arbitrary neighborhood classifications; arbitrary property condition classifications; unsupported shifts in valuation allocations as between land and improvements; inconsistent, discriminatory full inspection patterns; inadequate sales data and inadequate or non-existent application of trending factors; and specious alterations of established non-statistical valuations without corresponding adequate

non-statistical appraisal work. These defects caused wide margins and substantial over-assessments and under-assessments Town-wide. Moreover, the Vision Appraisal appraisal/re-appraisal process was carried out unlawfully and illegally and not in conformance with either the minimum requirements for certified appraisal/re-appraisal work in the State of Rhode Island or the certification/qualifications requirements of the Contract.

469. The property tax regimen resulting from the aforesaid flaws is systemically impaired and out of compliance with the legal requirement of Article 1, Section 2 of the Constitution of the State of Rhode Island that property tax burdens be fairly and equally distributed; and of R.I. General Laws § 44-5-12 that all properties subject to taxation be assessed at their full and fair cash value as of the assessment date, or a uniform percentage thereof not exceeding one hundred percent (100%). The appraisal work providing the foundation for said assessments and property taxes was also performed unlawfully under the Rhode Island Real Estate Appraisal Certification Act, R.I. General Laws § 5-20.7-1, yet was still embraced by defendants after they had full knowledge of this fundamental defect.

470. Plaintiffs and/or others have publicly challenged the integrity, accuracy, and legality and validity of the Vision Appraisal appraisal/re-appraisal work product and participated in multiple public forums for the purpose of articulating said challenges, and provided numerous written submissions to defendants with respect to the same.

471. Notwithstanding said challenges – and despite full knowledge of their contents – defendants have publicly and emphatically declared their intention to make the Vision Appraisal appraisal/re-appraisal work product the basis for assessed valuations effective December 31, 2008 for property taxes levied and imposed during 2009. Prominent among their

stated rationale is their desire to please the greatest number of their constituents. The circumstances are such that it is futile for plaintiffs to expect that defendants will not make the Vision Appraisal appraisal/re-appraisal work product the basis for assessed valuations effective December 31, 2008 for property taxes levied and imposed during 2009.

472. Similarly, plaintiffs and/or others have publicly and emphatically declared their intention to challenge the integrity, accuracy, legality and validity of the Vision Appraisal appraisal/re-appraisal work product and any certification of the tax roll or levy or imposition of property taxes by the Town of Barrington thereon. Plaintiffs and others have requested that defendants seek a legislative deferment of the time for completing assessed revaluations effective December 31, 2008, and defendants have failed and refused to do so.

473. By accepting the Vision Appraisal appraisal/re-appraisal work product and making it the basis for assessed valuations effective December 31, 2008 for property taxes levied and imposed during 2009, defendants act with full knowledge of the risks that said assessed valuations and corresponding taxes will be deemed invalid and that all ratable real estate within the Town of Barrington may have to be re-assessed effective December 31, 2008 and the corresponding burden of taxation re-allocated retroactively.

474. Plaintiffs lack any adequate remedy at law.

WHEREFORE, plaintiffs demand judgment as follows:

(a) Declaring that property taxes levied and imposed by the Town or Barrington based on assessed valuations effective December 31, 2008 established pursuant to the Contract between said Town and Vision Appraisal Technology, Inc. are not in conformance with the requirements of applicable law;

(b) Setting aside such assessed valuations and re-establishing them effective December 31, 2008, and correspondingly re-establishing and re-allocating (and/or providing a mechanism for re-establishing and re-allocating via bifurcated proceedings) the burden of property taxation in the Town of Barrington among ratable properties situated in said Town, all at defendants' expense;

(c) Providing plaintiffs and the class they represent with appropriate relief, including damages incidental to the foregoing;

(d) Awarding plaintiffs attorneys' fees and costs of suit; and

(e) Providing plaintiffs and the class they represent with such other and further relief as the Court may deem appropriate.
