




LAST WILL AND TESTAMENT OF MARCELLE J. JAMIEL

I, MARCELLE J. JAMIEL, of the Town of Warren, County of Bristol, State of Rhode Island, being of sound and disposing mind, memory and understanding, do hereby make, publish and declare this and this only as and for my Last Will and Testament in the following manner hereby revoking all Wills heretofore made:

FIRST: I hereby authorize and direct my Executor, hereinafter named, to pay all my just debts and funeral expenses.

SECOND: I give and bequeath my personal property and effects to my sons, J. ALLAN JAMIEL, MARK S. JAMIEL and JONATHAN R. JAMIEL. If my sons cannot agree upon the division of such property, the decision of my Executor shall be binding and conclusive upon all parties having an interest in my estate.

THIRD: I give, devise and bequeath my real estate and all furniture and furnishings located at 33 Miller Street, Warren, Rhode Island, to my son, JONATHAN R. JAMIEL.

FOURTH: I give and bequeath the sum of FIFTEEN THOUSAND (\$15,000.00) DOLLARS to my son, MARK S. JAMIEL.

FIFTH: I give and bequeath the sum of FIFTY THOUSAND (\$50,000.00) DOLLARS each to my sons, J. ALLAN JAMIEL and JONATHAN R. JAMIEL.

SIXTH: All the rest, residue and remainder of my estate, real, personal and mixed, of whatsoever kind and nature and wheresoever found and situate, of which I may die seized or possessed, or to which I may be entitled at the time of my decease, I give, devise and bequeath to my son, JONATHAN R. JAMIEL.

SEVENTH: I direct that in the event any beneficiary, or any other person in behalf of such interested person, shall contest this will or bring any proceeding calculated to defeat the purpose of this will, such action shall be construed as a

renunciation of any right to take hereunder, and such person shall take nothing.

EIGHTH: I hereby nominate and appoint my son, J. ALLAN JAMIEL to be sole Executor of this my Last Will and Testament and request that he be exempt from furnishing surety on his official bond.

NINTH: I hereby authorize my Executor, hereinafter named, (or any successor fiduciary) to sell at public or private sale any property, real or personal, which I shall own at the time of my death which is not specifically devised or bequeathed and to execute assignments, transfers and conveyances thereof as he shall deem proper, without seeking or securing authority from the Probate Court having jurisdiction of the administration of my estate.
